# Clarification on the composition of the Index and consequential change of name of the Index

The Sub-Fund is an index-tracking fund tracking the performance of the Solactive China Electric Vehicle Index (the "Index").

The Index represents Chinese companies that are active in the field of electric vehicles and therefore the index universe of the Index includes companies with significant exposure to electric vehicles and its related supply chain. The guideline with regard to the operation, calculation and maintenance of the Index will be updated with effect from 16 February 2021 (the "Effective Date") by Solactive AG, the Index Provider, to clarify that the Index represents Chinese companies that are active in the field of electric vehicles as well as batteries related to electric vehicles. It will also be clarified from the Effective Date that companies with significant exposure to electric vehicles and its related supply chain (including batteries of electric vehicles) will be included in the index universe of the Index.

Accordingly, the Index will be renamed as "Solactive China Electric Vehicle and Battery Index" to better represent the objective of the Index from the Effective Date.

#### Impact on the Sub-Fund

There will be no change to the fee level or cost in managing the Sub-Fund following the implementation of the changes set out above. There will be no change in the operation and/or manner in which the Sub-Fund is being managed, and there will be no change to the features or risk profile of the Sub-Fund.
