Implementation of ongoing charges cap

Mirae Asset Global Investments (Hong Kong) Limited (the "Manager"), as the manager of the Trust, hereby inform you that the ongoing charges figure in respect of each Product has been capped at 1.68% of the average net asset value of such Product since launch. Any ongoing expenses of each Product will be borne by the Manager and will not be charged to such Product if such expense would result in the ongoing charges figure exceeding 1.68%. This capped figure will be reviewed annually, and if this capped figure is changed, investors will be given at least one month's prior written notice. An increase or removal of the cap is subject to prior approval of the SFC.

The Manager believes that the implementation of the cap is in the best interests of the Products. The implementation will not materially prejudice the existing investors' rights or interests and there will not be any material changes or increase in the overall risk profile of the Products following the revision.
