To align with the revised name of the Index, the name of the Sub-Fund will be changed from "Global X China Electric Vehicle ETF" (Global X 中國電動車 ETF) to "Global X China Electric Vehicle and Battery ETF" (Global X_中國電動車及電池 ETF) from 12 March 2021 (the "Effective Date").
