#### **Suspension of Dealings of Mirae Asset Korea Equity Fund (the “Sub-Fund”)**

We are writing to you as a Shareholder in the Sub-Fund in relation to the consecutive period of public holiday in the Republic of Korea from 2 October 2017 to 9 October 2017 following the designation of 2 October 2017 as a one-off holiday by the government. As the Korea Exchange (KRX) will be closed during this period the Sub-Fund will not be able to perform any trades. Accordingly, the Company has decided to suspend valuation and dealings of the Sub-Fund from 2 October to 9 October 2017 (both dates inclusive).

Pursuant to the Prospectus of the Company (the “Prospectus”), the determination of the Net Asset Value and the issue, redemption and conversion of the Shares in a sub-fund may be suspended temporarily during periods where in the opinion of the Directors there exist unusual circumstances where it would be impracticable or unfair towards the Shareholders to continue dealing with Shares of the Sub-Fund

All instructions in respect of subscription, redemption and conversion of Shares in the Sub-Fund received by the Company during the abovementioned suspension period will be processed after resumption of valuation and dealing. The Sub-Fund will resume valuation and dealing on 10 October 2017.

It is reminded that pursuant to the Prospectus, any request for subscription, redemption or conversion shall be irrevocable except in the event of a suspension of the calculation of the net asset value.
