Shareholders may request the conversion of Shares registered by the Company on the basis of the relevant Net Asset Value per Share of the relevant Classes, less a conversion charge, carried out using the relevant formula as indicated in the current prospectus (the "Prospectus"). Please refer to the Prospectus and Information for Hong Kong Investors of the Company for further details on the applicability of the conversion charge. This Conversion Form should be (i) completed based on the Prospectus and the Information for Hong Kong Investors and the latest available annual report and accounts and the semi-annual report and accounts if published thereafter; and (ii) received by the distributors by 4:00pm Hong Kong time on a business day for further processing by the Registrar and Transfer Agent on the same day. Shareholders may be asked to pay the difference if the subscription fee of the Sub-Fund or Class of Shares into which the Shareholder wishes to convert exceeds the subscription fee of the Sub-Fund or Class of Shares which the Shareholder wishes to leave. All capitalized terms in this Conversion Form shall have the same meaning as in the Prospectus.
