What is this product?

Mirae Asset GEM Sector Leader Equity Fund (the "Sub-Fund") is a sub-fund of Mirae Asset Global Discovery Fund which is a mutual fund domiciled in Luxembourg and its home regulator is the Commission de Surveillance du Secteur Financier (CSSF).

Objective and Investment Strategy

Objective

The primary objective of the Sub-Fund is to achieve long term growth in the share price through capital appreciation, measured in US Dollars, of the underlying equity portfolio.

Strategy

The Principal Investment Manager and Investment Manager will seek to achieve the objective of the Sub-Fund by investing mainly in equities and equity related securities (such as but not limited to shares and depository receipts) of sector leading companies domiciled or exercising a large portion of their economic activity in the global emerging markets of the world including China, Brazil, South Korea, Russia, Mexico, Philippines, India, Thailand, Panama and South Africa.

Securities of "sector leading companies" refer to securities that are highly ranked (usually means first or second), or expects to be highly ranked in the future, in terms of market share, earnings or market capitalization within their respective country, region, industry, products produced or services offered.

Emerging market companies shall mean companies domiciled or exercising a large portion of their business in emerging markets, or companies listed on the stock exchanges of these markets.

The Sub-Fund's direct investments in China A-Shares (including those listed on the Small and Medium Enterprise Board, the ChiNext Board and/or the Science and Technology Innovation Board) through the Shanghai-Hong Kong Stock Connect and the Shenzhen-Hong Kong Stock Connect programs (the "Stock Connect") (as further described in the section headed "Additional disclosure in relation to Stock Connect" in the Information for Hong Kong Investors) shall not exceed 30% of its net assets. The Sub-Fund may also make indirect investments in China A-Shares via access products. In aggregate the Sub-Fund may invest up to 30% of its net assets in China A-Shares (through direct and indirect investment) and/or China B-Shares.

The Sub-Fund is a diversified portfolio and as aforesaid would invest in equities and equities-related securities including depository receipts. The Principal Investment Manager or the Investment Manager will have full discretion in selection of securities and the allocation of the Sub-Fund's assets. The Sub-Fund would invest its asset mainly in listed securities, and may also invest in other instruments such as cash and cash-equivalent instruments on an ancillary basis.

The Sub-Fund is actively managed and references the MSCI Emerging Markets Index (the "Benchmark") by seeking to outperform it. There are no restrictions on the extent to which the Sub-Fund's portfolio may deviate from the one of the Benchmark.

As permitted by and subject to the provisions of the Prospectus, the Sub-Fund may use financial derivative instruments (such as index futures and foreign exchange swaps), and employ techniques and instruments, for efficient portfolio management and hedging purposes only. The Sub-Fund will not invest more than 10% of its net assets in securities issued by or guaranteed by any single country (including its government, a public or local authority of that country) with a credit rating below investment grade.

Use of derivatives / investment in derivatives

The Sub-Fund's net derivative exposure may be up to 50% of the Sub-Fund's net asset value.

What are the key risks?

Investment involves risks. Please refer to the Hong Kong offering document for details including the risk factors.

1. Risk of investing in emerging markets

• The Sub-Fund invests in emerging markets such as China, Brazil, South Korea, Russia, Mexico, Philippines, India, Thailand, Panama and South Africa carrying higher risk than investment in a developed market (e.g. investment and repatriation restrictions, currency fluctuations, government involvement in the private sector, different auditing and financial reporting standards, possibility of limited legal recourse). Investment in some emerging markets also carries a higher liquidity risk than investment in a developed market due to a relatively low market volume in emerging stock markets. This may adversely affect the value of securities held in the Sub-Fund and the value of shares held by the shareholders of the Sub-Fund.

2. Currency / Foreign exchange risk

Underlying investments of the Sub-Fund may be denominated in currencies other than
the base currency of the Sub-Fund. Also, a class of shares may be designated in a
currency other than the base currency of the Sub-Fund. The net asset value of the
Sub-Fund may be affected unfavorably by fluctuations in the exchange rates between
these currencies and the base currency and by changes in exchange rate controls.

3. Risk of investing in equities and equity related securities

• The Sub-Fund invests mainly in equities and equity related securities and the value of the Sub-Fund may be affected by changes in the stock markets, changes in the value of individual portfolio securities, as well as by economic, political, and issuer specific changes. At times, stock markets and individual securities can be volatile and prices can change substantially in short periods of time. The equity securities of smaller companies are more sensitive to these changes than those of larger companies. This risk will affect the value of the Sub-Fund, which will fluctuate as the value of the underlying equity securities fluctuates.

4. Risks related to investments through the Stock Connect

• The relevant rules and regulations on the Stock Connect are subject to change which may have potential retrospective effect. The Stock Connect is subject to quota limitations. Where a suspension in the trading through the Stock Connect is effected, the Sub-Fund's ability to invest in China A-Shares or access the PRC market through the Stock Connect will be adversely affected. In such event, the Sub-Fund's ability to achieve its investment objective could be negatively affected.

5. Risks associated with Small and Medium Enterprise Board, the ChiNext Board and/or the Science and Technology Innovation Board

• The Sub-Fund may invest in the Small and Medium Enterprise Board ("SME Board") and/or the ChiNext Board of the Shenzhen Stock Exchange via the Shenzhen-Hong Kong Stock Connect and/or the Science and Technology Innovation Board ("STAR Board") of the Shanghai Stock Exchange via the Shanghai-Hong Kong Stock Connect. Investments in the SME Board, ChiNext Board and/or the STAR Board may result in significant losses for the Sub-Fund and its investors, and will be subject to additional

risks, including higher fluctuation on stock prices and liquidity risk, over-valuation risk, differences in regulations, delisting risk and concentration risk.

6. Risks related to investment in Mainland equity securities and PRC tax risks

- The Sub-Fund may invest in China and may be subject to the risks of investing in emerging markets generally as well as country specific risks relating to China.
- The value of the Sub-Fund may be more susceptible to adverse economic, political, policy, foreign exchange, liquidity, tax, legal or regulatory event affecting mainland China.
- There are risks and uncertainties associated with the current PRC tax laws, regulations and practice in respect of capital gains realized via the Stock Connects or access products on the Sub-Fund's investments in the PRC (which may have retrospective effect). Any increased tax liabilities on the Sub-Fund may adversely affect the Sub-Fund's value.
- Based on professional and independent tax advice, the Sub-Fund will not make tax provision for realized and unrealized capital gain derived from China A-Shares.

7. RMB currency and conversion risks

- RMB is currently not a freely convertible currency and is subject to currency exchange control and repatriation policies of the Chinese government.
- Although offshore RMB (CNH) and onshore RMB (CNY) are the same currency, they
 trade at different rates. Any divergence between CNH and CNY may adversely impact
 investors.

8. Risk of financial derivative instruments

 The use of financial derivatives instruments may expose the Sub-Fund to higher risks including market volatility risk, credit risk, counterparty risk and liquidity risk. In adverse situation, the use of financial derivatives instruments in effective portfolio management and hedging purposes may become ineffective and the Sub-Fund may suffer significant losses.


9. Risk of Foreign Account Tax Compliance Act ("FATCA")

• The Sub-Fund will endeavour to satisfy the requirements imposed by FATCA to avoid the imposition of FATCA withholding tax. In the event that the Sub-Fund is not able to comply with the requirements imposed by FATCA and the Sub-Fund suffers US withholding tax on its US investments (if any) as a result of non-compliance, the Sub-Fund may be adversely affected and may suffer significant loss as a result.

10. Investment risk

• The Sub-Fund is an investment fund. The Sub-Fund's investment portfolio may fall in value and therefore your investment in the Sub-Fund may suffer losses.
