#### Notice to Shareholders - Changes to FactSet China Global Leaders Index

Dear Shareholders,

Mirae Asset Global Investments (Hong Kong) Limited (the "Manager"), the investment manager of the Sub-Fund, hereby informs Shareholders of changes to be made by FactSet Research Systems Inc. (the "Index Provider") to the FactSet China Global Leaders Index (the "Index"), the underlying index of the Sub-Fund.

#### **Changes to the Index**

The index seeks to capture global growth leadership by focusing on PRC-related companies exhibiting higher revenues generated outside of the PRC, Hong Kong and Macau as a proportion of their total revenues, as well as possessing more global customer relationships in their respective industries. To ensure the Index objective is reflected, the following change will be implemented with effect from 12 July 2024.

"Having a total market capitalisation of USD100 billion or below" will be removed as one of the criteria for constituent selection.

## Impact on the Sub-Fund

There will be no material change or increase in the overall risk profile of the Sub-Fund following the changes. The above changes do not materially prejudice the rights or interest of the Shareholders of the Sub-Fund. For the avoidance of doubt, the investment objective and strategy of the Sub-Fund remain unchanged, and there will also be no impact on the acceptability of the Index.
